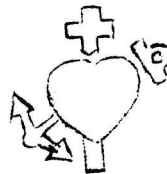

THE DIRECTORS' REPORT

Now that the settling in period of the newly-elected Board of Directors of our Association is over, the Board has begun to consider what you, the members, expect from your Association for the next 3 years.

The task is not as easy as it should have been, and there is lack of direction both from the Memorandum of Association, the by-laws, and from the members themselves.

For example, according to the Memorandum of Association, your Board should build and operate a church, a school, a social club, enter into business and operate for profit a milk bar, a restaurant, a hotel, reception rooms, and any other business you care to name; buy property for investment or rent, enter the stock and money market, operate a welfare agency, a hostel for the old, a nursing home. Enter into partnership with other organizations to achieve any of the above and do anything the directors think will provide (unspecified) benefits to the members.

No wonder everybody is confused and members apathetic.

This apathy is very disturbing. It appears that the only benefit members get is one or two subsidised functions a year, and the opportunity at every private gathering to lament the fact that after 60 years of operation, we are on the verge of collapse and dissolution.

It is not for the Directors to tell you what you want. You must tell them what you expect them to do for you. Otherwise anything they do will be criticised from one quarter or another and they either will do nothing or give up.

The problem is not insoluble. It can be solved if you, the members, show interest and participate a little.

There are two ways we can go about it. One is to come together one afternoon in a mini-seminar and arrive at a consensus. The other way is the less satisfactory of the two - to organise a survey.

The Directors are prepared to organise whichever method you choose, so please let them know by answering and returning the following questions:
