We print a letter from Michael G. Kailis in connection to the recent problems concerning the World Brotherhood: The letter is self explanatory. Unfortunately we were not able to be represented at this Special Meeting held in South Australia on November 10th, 1987.

# To All Castellorizian Societies in Australia From: Michael G. Kailis

- 1. During my recent trip to Greece, as instructed by the World Kastellorizian Brotherhood at the Annual Meeting in Perth, 21st & 22nd May, 1987, I contacted Dr. Hatzigiannaki, in regard to the above matter. I was accompanied by the General Secretary Stephan Scopelitis and my wife Patricia.
- 2. The Meeting was held in his surgery office. After considerable discussion I suggested that Athens should take the responsibility of the Presidency of the World Brotherhood, and asked if it would be acceptable to him. No firm answer or commitment was obtained. The matter was to be discussed by the Athens-Piraeus Association and although specifically requested, to the time of writing I still have received no reply or commitment from the Athens-Piraeus Association regarding this matter.

As a typical example of the Athenian-Pireaus Associations's uncoordinated approach to Kastellorizo, claiming that they are the Worldwide Kastellorizian Association (of Saint Constantine) donated a station sedan to the Island for transport to and from the Airport, which is redundant, as it is unsuitable and there is a more suitable vehicle in regular use supplied by the Geronikolas family of Rhodes.

- 3. I proceeded to Kastellorizo, pleased to see the Air Service operating and the airstrip and air terminal functioning. I would suggest that one item that the World Brotherhood might address, is the co-ordination of flights between Athens/Rhodes and Rhodes/Kastellorizo, and also the possibility of a coordinated weekend coordinated excursion timetable.
- 4. On arriving in the village I was far from impressed with the conditions on the island and the progress or rather, lack of progress, in the last two years. There is no doubt the Island needs a lot of direction, support and assistance from the World Brotherhood.

Any evidence of projected planning of any description by architectural or town planning development is lacking, despite the fact that there has been a lot of work done in this direction, unfortunately the Island has deteriorated again.

Certainly the restaurants are cleaner, but otherwise the state of general cleanliness or tidiness has deteriorated. Specifically the area around the wharf is an absolute disgrace from unused drums, bottles and crates and broken down tractors. It is a disgrace that this provides the first impression of the Island for the majority of visitors. Also I was disgusted to find animals once more roaming the village and fouling church-yards - a tradegy at the St. George of the Mountain. Furthermore, I was dismayed to note that people have been running around again with paint brushes and erecting signs claiming block of land they have no intention of building on.

On my return to Rhodes, I met with the President of the World Brotherhood, Parascho Kaillis and learned that he is no longer the President of the Rhodes body. There is also evidence that he is at odds with the new Rhodes Committee - a situation I am far from happy with.

I contacted the Kastellorizian Brotherhood of Rhodes - via Jack Geronikolas and met the Committee. We discussed our predicament with the relationship of the Athens- Piraeus Association, Rhodes Brotherhood and the World Brotherhood. The Rhodians are also deeply concerned with the situation and proposed the following solution.

- 1. The World Kastellorizian Brotherhood's Constitution now be registered in Australia.
- 2. A President be elected in Australia.
- 3. Registered offices be established in Australia.

Personally, I feel this could resolve our problem in the short term with full support from major bodies.

However, the longer term problem will remain especially with the recalcitrant Athens-Piraeus Association or group.

I intend therefore to call a Meeting of all Presidents while Parascho Kaillis is in Adelaide early in November to make every effort to resolve this problem. I will be contacting you directly by phone to arrange the time and venue.
