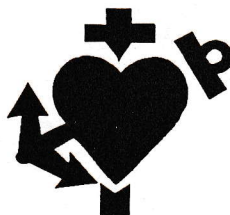

## **PRESIDENTS REPORT**

This current Board took office in 1988 and I express my thanks for their support over the past 2 years. Judging by their attendance at our monthly Board meetings I must say that this has been a very successful working Committee, thank you for your support. Most of us are involved in other activities and have business and family commitments and it is often necessary to remind Members that all Board Members are honorary and give their time because they believe in the work we are trying to do.

### **WELFARE**

The Board would like to thank Mrs Christine Dimer for her assistance in visiting the aged and the infirmed at hospitals, at their homes and at nursing homes. This service will continue until all members are visited and assistance given if necessary.

### **FEASIBILITY STUDY**

Today we tabled a feasibility study prepared by our architects Alan Lovell and Associates. This study is the most comprehensive ever undertaken by the Society and I hope that members can come to a conclusion as to which option is the best for our members.

### **CASTELLORIZIAN NEWSLETTER**

Our Newsletter which commenced publication in 1982 has now published 71 editions. I thank all those who have contributed to the letter and if any errors have been made I apologise but I ask members to keep in mind that the position of editor is an honorary one! As always the future of the letter which keeps members informed will also have to be reviewed in 1991. Each month we distribute approx. 270 newsletters, if you multiply this by the number of persons in each family you will see that our coverage is quite extensive.

### **CONSTITUTION**

Our current articles of the Association are now 10 years old and it is important in view of the declining membership that our articles are brought up to date. At todays Meeting we will be seeking to elect a Sub committee to bring our artciles up to date.

### **ELDERLY CITIZENS**

Our Club Rooms will continue to be used by the Greek Elderly Citizens of Port and South Melbourne. They have made numerous donations financially and have replaced the Clubs refrigerator and stove. They also keep our Club rooms in reasonable clean order - we thank them.

### **FUNCTIONS**

After many years as a Board member and President (a total of 22 years in all) I often wonder and have never been able to understand what members expect from a Board. In 1989-90 we organised a total of eight various functions, together with the functions organised by our Youth Committee making a total of 9. Members in their own minds must know just how many they have attended if any.

### **ELECTION**

At our A.G.M. in 1989 12 financial members were present together with 10 Board members, a very disappointing and sad indication of what the future holds for our Society. I hope that todays General Meeting is a better reflection of our current membership.
