GOYA has been financially successful in recent years, and it is an irony that this success sowed the seed for its present difficulties. Some past committee members forgot they were essentially committee members of a voluntary youth organisation and not entrepreneurs. We now have the problem of owning two buildings of which one is under litigation to ownership, and the other has a large mortgage. In addition, tragically, some executive members of the committee could not resist the temptation of the monies that they were responsible for on behalf of the club and it's members. Sadly it has resulted in the charge of theft being placed by the police against an expresident of the club.

These problems resulted in a number of past GOYA committee members and presidents returning to the present committee to help the club and set it on a steady path once again. I can say that for the older Goyas, there are fond memories of their past involvement in the club, and a desire to secure it's future for their children and grand children.

This concerned group and the committee, decided to take the unprecedented step of holding an extraordinary general meeting within the legal requirements of the GOYA constitution.

The meeting was arranged and duly held on the 10th June, where just over 60 GOYA members attended, just within the constitutions quorum requirements.

The meeting was turbulent and traumatic for many attending, but it did allow members to voice their anger and frustration. A number of positive resolutions were voted for, details of which can read in the next GOYA newsletter, out in two or three weeks. These included the endorsement of the extra members to the committee.

The present committee is putting democratic procedures in place for the future running of the committee, and sorting out the financial maze for the long term well being of the club.

The Annual General Meeting is in early October, and it is hoped that by then the club will be on a solid foundation, and continuing its role and activities in the Greek Community for our youth, a role which it has carried out in the past with excellence.

The present committee makes a please to the Greek Community to help GOYA in its hour of need so that it's future can be assured and it can provide the cultural, social, and sporting activities for which it is renowned.

The GOYA committee has organised a GOYA Forum for members and friends of the Club, to be held on Sunday, September 8th at 3p.m. at 400 Sydney Road, Brunswick. Afternoon Tea will be provided. The purpose of this forum is to activate interest in the club, to get to know the committee and to exchange ideas. The committee hopes that a good sized crowd will attend.

This article is taken from Neos Kosmos July 8th, 1991 The article is dedicated to the "Greeks of Richmond" We thank Neos Kosmos for permission to print this extract from the above article.

"Spiros Galatis 50 years in the same shop in Bridge Road, Richmond.

Spiro Galatis arrived in Australia in March, 1938 when he was approx. 20 years old. In his first 3 years he bought his own shop in Bridge Road, Richmond and now after 50 years is still in the same shop.

Spiro is quoted as saying "Even up to this day I believe that a person, for as long as he lives must be occupied with something, if I were to stop working I would become ill."

He came as a young man from Ithaca, the trip by boat "Esperance Bay' which took 40 days. His older brother Gerasimos had arrived previously in Australia in 1924.

Spiro liked Melbourne from the first time he saw it. It was so large and the people were likeable. For three years he worked with his brother who had a chocolate factory in Bay Street, Port Melbourne.

In 1939 his mother Mrs. Rodamanthi Galatis together with brother Vasili arrived in Melbourne.

Spiro together with brother Vasili combined to buy the shop in Richmond in 1941, the shop which still has the same name was "The Don Cafe".

They worked 7 days a week, Spiro remembers it as if it was today.

3 days after they bought the shop, 7th December, Japan declared war on Australia. People were very frightened particularly when the Japanese were sighted close to Sydney.

All that time Australians were not sympathetic towards foreigners so it was helpful to put up the Australian flag in the shop to show that we were on the side of the Allies. Business went very well after that, four to five years later Vasili got married and left to live in Adelaide where he still lives today:

Over the next few years things were tough their wasn't many jobs around. Those who had shops did very well because American Forces had arrived in Australia spending a lot of money.

Spiro had no problems getting on with his Australian friends and customers and in the 50 years he has been in business some of his best friends and customers are Australians. Today Spiro is 73 years old and he has never worried about tomorrow and he feels that this is the reason that he can still cope after 50 years.

When he first came to Richmond in December, 1941 it was like a country town with some dirt roads, horse and buggies. People could walk safely and freely in the streets, times have now changed.

I remember the horse troughs specially placed to water the horses, now its garages watering cars. Who would have thought in 1940 that we would have T.V. video, and that man would walk on the moon and we would be able to travel to Greece in 20 hours. In the 40's their was only one Cinema in Richmond Hoyts Cinema in Bridge Road.

In the 60's we had our first Greek Cinema in Richmond. His biggest memory in those 50 years were the Olympic Games held in Melbourne in 1956. Because the stadium was in walking distance from Richmond he has a souvenir of a ticket to see the basket ball.

Never will he forget the Opening of the Olympic Games when the Greek flag came first on the big M.C.G. Ground he cried with emotion. Also the last day of the Games when all Nations celebrated together that's why the Games were called the Friendly Games.

He recollects that he was married practically in the shop. He met his wifes father who was a regular in his shop George Chrisohos who came from Castellorizo and that is how he came to meet his wife Eva Chrisohos. She worked in his shop for a year before they were married.

They have a daughter Dionisia (Denise). The Chrisohos family had lived in Richmond for many years, Evas mother and father were both from Castellorizo Triandafillia and George.

At the end of the interview Eva Chrisohos interrupted to say that now is the time to visit Greece Castellorizo and Ithaca.

Reference: Report of Sub-Committee Review of By-Laws.

Firstly, congratulation are in order to the Sub-Committee for their comprehensive and timely review of the by-laws of our Association. I fully agree with their conclusions and suggestions as to the future of our Association and submit the following comments for their personal and appropriate action.

- 1. The ethnic culture of our forebears must at all costs be preserved for eternity and it is indeed alarming that the second generation onwards, of those illustrious Castellorizians that settled in Australia are failing to participate in these ideals. As future generations continue to proliferate and assimilate into other cultures, so the danger of our ethnic origins being forgotten and lost forever increases.
- 2. I recommend that an appropriate form be forwarded to all financial members requesting their approval/non approval of the proposed action of the sub-committee. This way a documented record of what I am sure will be an overwhelming consensus of approval for the proposed review of our by-laws.
- 3. "Statement of purposes" para. 14 (c) needs classification, as no time limit is imposed on the three members forming the management of the proposed Trust; a time limit of 5 years would be appropriate. The incumbents of A and B are self explanatory, however the three positions of (c) should be **elected** by the Members, rather than be **selected**, as this would remove any suggestion of bias by the Committee. A supply valve should also operate whereby any incumbent could be relieved of duty subject to a majority of Members so indicating. This way any friction or descention which may occur would be obviated.
- 4. Rules of the Association page 6 (1): I would assume, there will not be too many "natural persons" born in Castellorizo in the foreseeable future, and perhaps residents of "Australia not necessarily "Victoria" should also be eligible for membership.
- 5. Obligations of Public Officer page 9 (4): Perhaps for such an important decision as (4) indicates, surely any such decision must be left to a general meeting to decide rather than the Public Officer, therefore after the word"Association" in para. 4 page 9 include the wording "in accordance with the decision of a general meeting."

In conclusion I once again heartily congratulate the review Committee on a difficult job well done, and fervently hope the Castellorizian Association will prosper and grow in the years to come.
